Virtual Board Meeting

1. Meeting to Order

The virtual board meeting was called to order at 4:02 PM on Thursday, February 16, 2023 by the Chairman of the Board, Tyson Judy.

2. Board's Mission

Chairman Judy reminded the Board that the purpose of the Board is to safeguard the public health, safety and welfare by regulating persons engaged in the practice of medical imaging.

6. Agenda

7. Board Meeting Minutes

a. January 19, 2023
