- b. Director Browning reported that the WV Society of Radiologic Technologists and the American Society of Radiologic Technologists are in opposition to Senate Bill 195. After careful review and consideration of all available information, Board Member Snead made a motion to support the WV Society of Radiologic Technologist and the American Society of Radiologic Technologist opposition to Senate Bill 195. Board Member Hoffman seconded the motion, and the Board unanimously approved.

- c. Director Browning reported that she had notified the Senate Committee on Government Organizations and requested to speak to the committee regarding Senate Bill 195. After careful review and consideration of all available information, Board Member Hoffman made a motion for Director Browning to present the previously approved Board response in opposition to Senate Bill 195. Board Member Snead seconded the motion, and the Board unanimously approved.
