## License Management System

The Certemy Licensing System went live on September 15, 2020. This system is available 24/7 online and allow our licensees to print licensing documents anytime.

## MRI

It is illegal to perform MRI without an MRI License or a MRI Apprentice License.

## Apprentice License

Apprentice License must be acquired for supervised clinical experience in MRI and Nuclear Medicine.

## Nuclear Medicine

NMTCB and ARRT require didactic and clinical competency to apply for the Nuclear Medicine Credentialing Exam.

## PET

Licensed Nuclear Medicine technologist must be credentialed in CT, licensed in Radiography, or have passed the WV CT Fusion test to operate the CT Portion of the PET scan.

## Text Messaging

It is illegal to work with an expired medical imaging or radiation therapy license. The Board is now sending text messaging expiration reminders.
